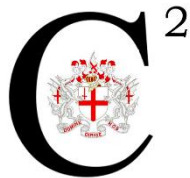
Bank Account: We have a new bank account to reflect our new name as City Consorts Limited. Please do not make any bank transfers to the old Society account as we will not receive it.
